Role Overview			

We currently undertake software development for a number of products relating to metering and billing, working with internal teams and external stakeholders. This role will help to support the Product Manager in the process of shaping and administering the future development of these hardware products.

A keen attention to detail, ability to understand how people interact with software, and strong organisational skills will be required to make sure that we not only develop our software efficiently, but also create intuitive and easy to use systems.

This role will work closely with our existing Product Manager, and supported through external training, will learn the skills required to produce great quality, useful products in an agile working environment; ultimately progressing towards managing a sub-set of our products independently.



## Key Responsibilities

- Understanding our full range of products and services and how these are reflected in the functionality of our system, as well as the functional user-perspective use of features
- Developing a deep understanding of the real-world requirements of customers, to refine how we deliver functionality within the software
- Supporting the Product Manager in implementing the development roadmap, including writing documentation for functionality and supporting day-to-day workload alongside the Product Owner and Software Development Manager.
- Ensuring that changes to the system are beneficial for the whole system and all clients
- Supporting in sprint planning for developers, and helping to undertake the agile development process
- Engaging with clients to get feedback on features to be created and that have been recently created
- Helping to maintain the backlog by clearly expressing the backlog items and ordering them to best achieve goals.
- Ensuring that sprint targets are regularly accomplished, and where they're not understanding the reason and providing suggestions for actions that might help
- Helping to create specifications in the form of actionable user stories as well as building business acceptance criteria prior to the development of a functionality
- Facilitating internal meetings between development and business to ensure constant collaboration throughout the development process
- Maintaining instructional content for new features
- Being involved with ongoing testing efforts to ensure the functionality meets the criteria and would hence satisfy the customers' needs.
- Providing training to internal team members including full system training, top up training, and training on new features
- Attending update meetings with clients to ensure communication and feedback is collected.
